



A RESOLUTION APPROVING A 2021 AMENDED BUDGET FOR THE CITY OF DYER, ARKANSAS.


BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DYER, ARKANSAS, AS FOLLOWS:
