The city council meeting for the city of Dyer was called to order by Mayor Paul Brown at 6:30 pm. The pledge of allegiance was said.

Public Forum:

Evie Goff had passed out a list of concerns during the last council meeting and asked the council if they had an opportunity to look at them and wanted to know their thoughts. Alderman Rowell asked for a general update. Alderman Satterfield asked for executive session. No one seconded. Alderman Satterfield stated this happened before she was even here, and she felt she didn't know anything about this. Recorder Treasurer asked if we could do executive session to bring her up to speed or just discuss it out in the forum. It was decided to bring her up to speed out in the meeting. The question was, were the liens placed against the property. The property was abandoned, and the city came in and cleaned it up and we were to put a lien on the property for cleaning the property up. 911 Rhoades Street is still in court. They are looking to file a quit claim to the city. City attorney did not file the liens and he paid the liens out of his pocket because the liens were not filed. Mayor asked why the liens did not get filed. City Attorney stated he did not have a good explanation. There were changes in office personnel and Veronica was not here to remind him of this. What are we going to do to keep this from happening again? Issues like these will be placed on old business until resolved. Evie asked about a case in litigation that was referred to during the Morrell lawsuit that was mentioned in passing and has sent emails requesting case information and how to look it up and has not gotten an answer, she asked what am I going to have to do, call the attorney general to get my answer? Evie asked would this not make a difference on how you all would have voted. Alderman Donna Staton stated that the water per door fee was legal but the door charge for sewer rates should have gone before a public hearing and did not, so it was not legal. Veronica spoke up and stated that the apartments was not charged a \$25 door fee for sewer they were given \$25 door fee per water meter and \$16.01 for sewer. Evie wanted to know the name of the litigation so she can read up on it and see if it might have made a difference in the decision made to settle the lawsuit. Evie states that the bottom line is that the attorney did not do his job and the council must make sure he does his job. Alderman Rowell states that old business is never brought up from meetings to meetings.

Mayor handed out notice from Alma that the water rates will go up in 2023. Mayor states that we are not planning to raise our rates currently. Questions were asked what is the wholesale rate we are being charged? We will be asking what our wholesale water rate is. Water meters are hopefully going to be here in September. Alderman Donna Staton asked if the customer has a leak can they get into the box and turn the water off and was told no by Water operator. You are supposed to have a shut off valve between the meter and the house. Police officers and mayor both have a key and water key to shut off the meter if they get called.

Public works:

Rick McClellan states he wanted to brag on Kim and all her hard work with the last big issue when the sewer pumps went down. Kim cleaned the holding tank out and found everything from a beach ball to a fishing pole and a mop head. We are going to have Truman's come pump every quarter. If you see a manhole cover off that is a bad thing, and we need to know to replace it. Mayor asked how to get a text message or call when the pumps go down and Rick McClellan is going to work on getting this started.

Police Chief is in Texas with a drug dog being trained. No cost to the city except for motel bills there. Food has been donated to the city for the dog.

Fire Department:

Joseph Sanders states 1 brush fire mutual aid for district 7 and 6 medical calls. We are getting donation of medical equipment. We will be doing first aid training. The bags will be in their car for responders.
